

## CONSENT FOR PROCESSING OF PERSONAL DATA OF CLIENTS

By registering on the website <http://uxwithjanda.com/>, an individual hereby accepts this Consent for Processing of Personal Data of Clients (hereinafter – the “Consent”). The registration on the website shall be deemed as the acceptance of the Consent. Acting freely, by his/her own will and in his/her own interests and confirming his/her capacity, an individual hereby provides his/her consent to SKILLBOX LLC, the owner of the website <http://uxwithjanda.com/>, with its registered address at 105005, Moscow, 11 Baumanskaya str., bld. 8, premises 3, flat 4, , to process his/her personal data in accordance with the following terms and conditions:

1. The Consent is given for processing of personal data with or without automatic means.
2. The Consent is given for processing of the following my personal data:
  - a. Personal data, which is not special or biometrical:  
surname, name, middle name; date of birth; place of birth; details of the identification document; address; contact telephone numbers; e-mail addresses.
  - b. Special personal data.
  - c. Biometrical personal data.
3. Personal data is not publicly available.
4. Purpose of processing of personal data: sale of services; delivery of online course completion certificates; sending of news and advertising newsletters; maintenance and updating of the customer base.
5. Personal data processing may involve the following actions: collection; recording; systematization; accumulation; storage; rectification (variation, revision); extraction; use; transfer (expansion, provision, access); blocking; deletion; destruction.
6. Provided personal data may be processed by the following third parties under the instruction of SKILLBOX LLC: Legal company "Chastnoe pravo" LLC, OMNI SUPPORT SYSTEMS LP, amoCRM JSC, FSUE Russian Post, PIXELLE LLC, ALFA-BANK JSC.
7. Personal data may be processed until the expiration of terms of the processing of personal data as it is defined in the Offer. Processing of personal data shall be terminated at the request of the personal data owner. Storage of personal data recorded on paper shall be carried out in accordance with Federal Law No. 152-FZ "On Archival Affairs in the

Russian Federation" and other regulatory legal acts related to archiving and archival storage.

8. The personal data owner or his/her representative may withdraw his/her consent for processing of personal data by sending an appropriate written notice to SKILLBOX LLC or to its representative to the address mentioned in the beginning of this Consent.

If the personal data owner or his/her representative withdraws the consent for processing of personal data, SKILLBOX LLC may continue processing such personal data without consent of the personal data owner on the grounds referred in paragraphs 2–11 of part 1 of Article 6; part 2 of Article 10; and part 2 of Article 11 of Federal Law No. 152-FZ “On Personal Data” dated 27 July 2006.
10. This Consent shall be valid until the termination of the processing of personal data in accordance with articles 7 and 8 of this Consent.
